YOU WILL BE CONTACTED BY A FIRE PREVENTION INSPECTOR TO DISCUSS YOUR APPLICATION AND SCHEDULE A SITE INSPECTION IF REQUIRED. ANY APPLICANT EXCEEDING THE ALLOWED EXEMPT AMOUNTS ARE REQUIRED TO OBTAIN A **\$250 FIRE DEPARTMENT PERMIT**.
