2. **Fire Equipment Locations/Inventories, Page 5, III, Specific Scope of Work, information for (22) Lift Station, is deleted and replaced by the following:**
  - (22) **South Lift Station - 4376 So. Greenfield Road**
    - 1 Fire panel Fenwalner model 6000  
Protected with FM2000
    - 2 pull stations
    - 2 abort buttons
    - 3 fire extinguishersNo sprinkler and back flow preventers
  
3. **Revised Attachment 5 – Bid Price is attached, which reflects the order of items as they appear in Scope of Work, the addition of five locations listed in the Scope of Work, and Page 2 of the original Attachment 5.**
  
4. **Question:** I'm looking through Addendum No. 1 and it looks like the revised bid price sheet is still missing four locations: 1. 85 East Civic Center Drive – Fire; 2. 75 East Civic Center Drive – Police; 3. Parking / Firing Range / Mechanical; 4. 55 East Civic Center Drive – Courts; --- I do not see these four locations on the revised price sheet.

Also, page 27 of the original bid had a few line items for extinguishers and labor rates. Should these still be included on the revised price sheet?

**Answer:** All of the areas you list (1. - 4.) fall under Item #31 on the Price Sheet (Public Safety Complex). You will note on Pages 15-16 of the revised Scope of Work, Fire Equipment Locations/Inventories, this is how they are listed. There is a heading for Public Safety Complex, then

all four of the areas fall under this. So you need to submit a price that rolls up to a total for all of Public Safety, including the main Public Safety Complex, and that also includes Fire, Police, Parking/Firing Range and Courts.

The items listed on Page 27 of the original bid (labor rate and extinguishers) should still be included. We were only revising the first page of Attachment 5 – Bid Price. However, we are attaching a revised price sheet that also includes Page 2.

All other specifications, terms and conditions of the solicitation shall remain unchanged.
