Town of Gilbert Street Light Shading Policy

1. The decision of whether to approve a request to alter a streetlight shall be at the discretion of the Town. In determining whether to approve a request, the Town will consider several factors, including the location of the streetlight, safety issues, and the extent to which light from a streetlight extends onto private property.
2. Only streetlights found on residential streets and some collector streets will be considered for alteration. Streetlights on collector streets without a sidewalk, on the same side of the street as the streetlight, may be altered. Streetlights on arterial streets shall not be altered.
3. Only the light pattern that is directed to the rear (pole side) of the streetlight may be altered.
4. A portion of the lens of the streetlight will be altered by painting, or otherwise covered, to reduce light emitted to the rear (pole side) of the streetlight.
5. No external shields will be attached to a streetlight.
6. Requests to alter streetlights will be made in writing on a form provided by the Town. Persons making a request must agree to the provisions of this policy.
7. The person requesting that a streetlight be altered shall obtain written approval from all neighbors, whose property is located in whole or in part, within a one-hundred (100) foot radius of the streetlight on a form provided by the Town.
8. The completed form will be reviewed and upon approval or denial the applicant will be contacted.
9. The person requesting that a streetlight be altered shall pay the alteration cost prior to the work being scheduled.
10. Nothing in this policy shall create liability for the Town for injuries or damages which may result from alteration of a streetlight. If the Town determines it is in the best interest of the Town or its residents to remove the alteration, the Town may do so.
