STRATEGIC INITIATIVE: Community Livability

This supports Community Livability by allowing residents to select local officials who represent them.

RECOMMENDED MOTION

A motion to adopt a Resolution accepting the Canvass of the Election for the November 8, 2016 General Election.

Following adoption of the Resolution the Mayor will present the Certificates of Election.

BACKGROUND/DISCUSSION

The Town held a General Election on November 8, 2016, for the purpose of electing two Councilmembers. A.R.S. § 16-642 requires that the governing body holding an election, canvass the election not less than six days nor more than twenty days following the election.

Maricopa County Elections provided election services to the Town. Services included securing polling locations, training and coordination of election workers, providing equipment, and tabulating ballots.

A total of 108,927 or 80.31% of Gilbert’s 135,630 registered voters cast a ballot in the General Election. The Town did not hold a General Election in 2014. Turnout at the General Election in 2012 was 77.83%.

A total of 2708 early ballots were cast at the Gilbert Municipal Center. The early voting site was open to any registered voter in Maricopa County. Data on the number of early ballots cast in the General Election is not available at this time.

The attached Resolution contains the official results of the General Election. Scott Anderson and Jared Taylor were elected as Councilmembers.

FINANCIAL IMPACT

STAFF RECOMMENDATION

Staff recommends adoption of a Resolution declaring and adopting the results of the General Election held on November 8, 2016.

RESOLUTION NO. 3883

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF GILBERT, MARICOPA COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON NOVEMBER 8, 2016.

WHEREAS, the Town of Gilbert, Maricopa County, Arizona did hold a General Election on the 8th day of November 2016 for the election of two Councilmembers; and

WHEREAS, the election returns have been presented to and have been canvassed by the Mayor and Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Gilbert, Maricopa County, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said General Election, as shown by the poll lists, as set forth in Exhibit A, was 108,927.

SECTION 2. That the number of provisional ballots was three thousand one hundred thirty-nine (3,139), and that voters found to be ineligible were seven hundred fifty-four (754).

SECTION 3. That the votes cast were as follows:
