NOTICE OF RIGHT TO UNCLAIMED/ABANDONED PROPERTY**

Pursuant to Gilbert Code, section 2-391 et seq., the Town of Gilbert, AZ hereby gives notice that **ALL TRUE OWNERS OF THE UNCLAIMED/ABANDONED PROPERTY AS LISTED ON THE TOWN WEB SITE** (www.gilbertaz.gov) AND MAIN BULLETIN BOARD (50 E. Civic Center Drive) MUST SUBMIT A CLAIM OF OWNERSHIP WITHIN 30 DAYS FROM THE DATE PUBLISHED to recover ownership of property (various items) held by the Town of Gilbert Police Department. After 30 days, the Town may exercise its right to destroy, keep for Town use, donate to charity, or sell the property at public auction.

ANY PERSON WHO BELIEVES ANY OF THE PROPERTY LISTED was stolen and may rightfully belong to him must make a claim by contacting the Gilbert Police Department Property & Evidence Section, 480-635-7166, Monday - Thursday 7:00 a.m. to 5:30 p.m. Claimants must possess and show valid photo identification.
