INSTRUCTION SHEET: COMMUNITY SERVICE FOR THE GILBERT MUNICIPAL COURT

1. HOW DO I COMPLETE COMMUNITY SERVICE?

Community service hours must be complete for a **NON- PROFIT organization** and must be submitted on a Gilbert Municipal Court “COMMUNITY SERVICE REPORTING FORM”. Additional reporting forms can be obtained online: <https://www.gilbertaz.gov/departments/court/forms> It is recommended that you locate a community service agency immediately.

2. HOW DO I SUBMIT MY COMMUNITY SERVICE HOURS TO THE COURT?

Verification of completing community service hours can be submitted by turning in the “COMMUNITY SERVICE REPORTING FORM” to the Court by mail, fax, by drop box (located outside the front entrance to the Court building) or in person at 55 E. Civic Center Drive, Suite 101, Gilbert, AZ 85296. **Community Service hours must be submitted to the Court by the due date ordered.**

3. WHERE CAN I COMPLETE COMMUNITY SERVICE?

The following are only a portion of the agencies that are acceptable for the completion of community service for the Gilbert Municipal Court. **Any verified non-profit organization is acceptable.** Other acceptable agencies include; churches, schools, and food banks. Community service can be completed in any city or state. Please note: COMMUNITY SERVICE CANNOT BE PERFORMED THROUGH ONLINE “EDUCATION” COURSES (EX: Terra Research, Logan Social Services, Caffeine Addiction Assoc). We also cannot accept hours from “Feed My Starving Children” as we are unable to verify the hours.
